From the Executive Director

Survivors are the true definition of strength, resiliency, courage, and hope.

Survivors share their fears, dreams and accomplishments with us. They share how the fear of the unknown can be paralyzing, but they do go on to share how they overcame that fear. For some the answer is confiding in someone, calling an attorney, or coming to a support group at Artemis.

Sometimes after that scary first step our advocates hear, "Thank you for believing in me. I don't think I would have made it through (the process of getting a Civil Protection Order) without your help." Or "I feel a little better, and I know it comes with time, but I feel better in my soul. Thank you."

The staff at Artemis work from a client-centered, trauma informed approach, knowing each survivor has their own unique experience. This is why the advocates engage in detailed and individualized safety planning with each survivor.

In 2023, we added a mobile health advocate in partnership with Ohio Domestic Violence Network. This advocate works to increase survivors' access to healthcare services, education and information. We have partnered with Equitas Health to host the MOVe Health Center in the parking lot for easier access for survivors once a quarter.

We are so incredibly proud to serve alongside the many survivors who take courageous steps to increase their safety and their children's safety every day.
